As the grant progresses over the next 3 years, current Board members will be added as signers and those replaced will be removed. Treasurer Starns and Chief Rhodes will be meeting at Umpqua Bank on Tuesday, August 16, to open the new account. The minimum dollar amount needed to open the account will be transferred from our existing money market account.

Motion passed unanimously.

Annexation on Krista Lane – The Board approves the Annexation of a property on Krista Lane, and President Reardon and Secretary Ikola have signed the required Douglas County form for return to the property owner.

Fire trailer – Will be stored at LRFD until the Umpqua Fire Instructors Association create procedures and update maintenance of the vehicle. It will be used for training while it is here.
